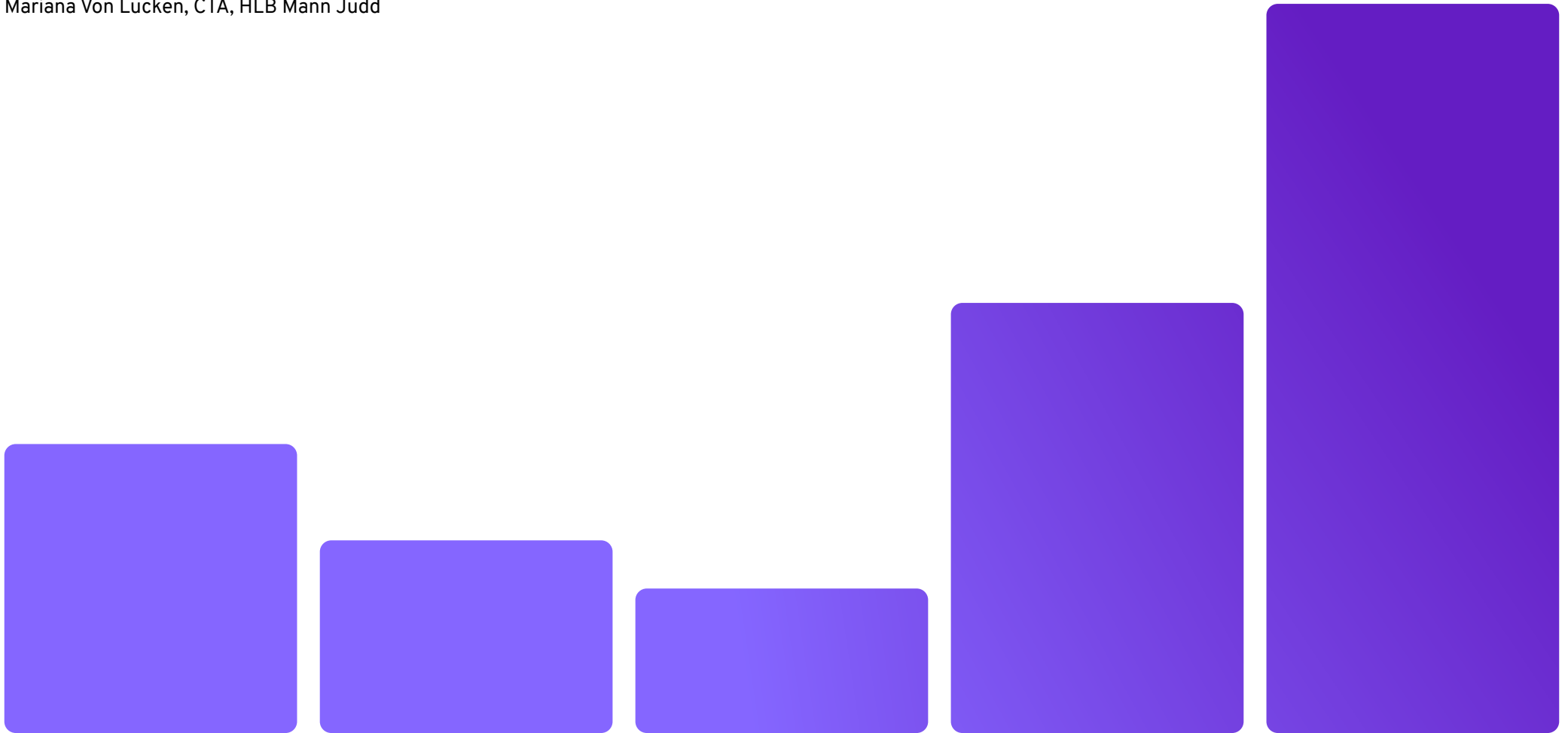

11.00am – 12.00pm	<p>Session 3: Stepping through the Imposter Syndrome</p> <p>Imposter syndrome is termed as feeling like a fraud or worrying that you will be “found out” for not knowing enough, even when you've truly earned your success. It's a common echo in the halls of success, with one KPMG study revealing that 75% of female executives across a variety of industries have experienced imposter syndrome in their career, a feeling of inadequacy and self-doubt that makes them question if they are qualified enough despite having significant education, qualifications and experience. It's...</p> <ul style="list-style-type: none">– Saying yes to a task (when you really want to say no) to prove your value to others– Telling yourself that you are not ready or it's not the right time to pursue an opportunity– Downplaying or minimising your contributions– Leaning on certifications or formal education to prove value– A persistent feeling of falling short (of often unrealistic expectations); and– Despite being high performing you struggle to experience success on the inside. <p>Women are often great at validating others but are harsh critics of ourselves. One thing we know for sure is that imposter syndrome is not rooted in objective reality. The self-doubt pattern of imposter syndrome exists in our individual perception of ourselves and the good news is that for this reason we have the power and potential to challenge and change this.</p> <p>The golden opportunity here is to learn to make friends with your inner critic – to right size that negative talk so it no longer overshadows every decision and action. Bus

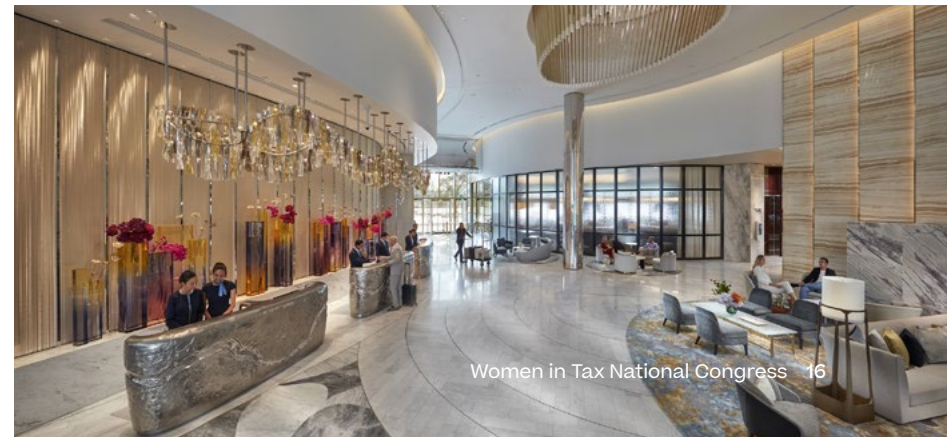
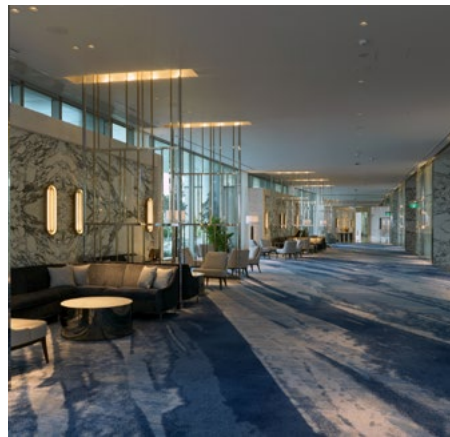
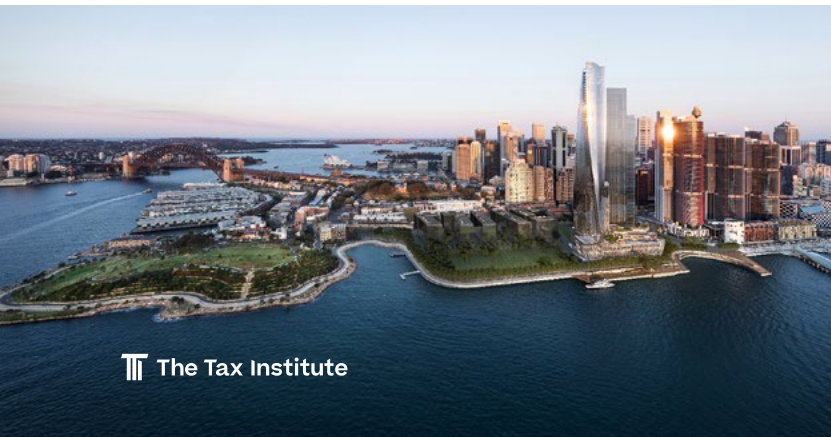
